

FREE BROADBAND FOR SIX MONTHS PRIZE DRAW

TERMS AND CONDITIONS

1.1 One (1) selected entrant will receive 6 months of their current broadband package for free. Single monthly charge for line rental and broadband only. Excludes additional call packages and features such as Anytime Calls and any other charges.

1.2 The prize is non-transferable, non-refundable and non-changeable. There is no cash alternative to the prize.

1.3 THE PHONE CO-OP reserves the right to award a substitute prize of an equal or greater value if the stated prize becomes unavailable.

1.4 THE PHONE CO-OP reserves the right to temporarily suspend, cancel or vary the Prize Draw at any stage if deemed necessary in its opinion, or due to circumstances beyond its control, and will use reasonable endeavours to minimise the effect on participants to avoid disappointment.

2 How to enter

2.1 No additional purchase necessary to enter.

3 Start and closing date

4 Eligibility

4.1 The Prize Draw is open to legal residents of the UK

4.2 Maximum one (1) entry per person via Feefo. Use of multiple identities is not permitted. Use of automated entries, votes or other programs is prohibited and all such entries will be disqualified. If you are selected as a winner and THE PHONE CO-OP subsequently discover that you have entered multiple times, THE PHONE CO-OP reserve the right to withdraw the prize.

4.4 Employees (and their immediate families) of THE PHONE CO-OP or any of its group, affiliated or associated companies, agents or any other person connected with the Prize Draw are not permitted to enter.
